1.	Clause 2.1.4 /section-II	<p>We are writing to express our interest in bidding as an MSE for your tender **No. CON/DCONT/TANK CONT/2025**. However, we have observed that the financial qualification criteria stated in **Clause 2.1.4** of the tender document require a minimum average annual turnover of **Rs. 12,25,00,000/-** over the last three financial years (2021-2022, 2022-2023, 2023-2024) and the current financial year up to the last day of the month prior to the tender invitation.</p> <p>As per the **Government of India's MSMED Act of 2006**, a **Micro Enterprise** is defined as an enterprise where investment does not exceed **₹1 crore** and turnover does not exceed **₹5 crore**. Given this definition, an MSE like **Ariser India**, despite its capability and interest in bidding, is effectively disqualified from participation due to the specified turnover requirement.</p> <p>We kindly request you to consider providing an exemption or relaxation in the financial qualification criteria for MSEs in alignment with government policies promoting small enterprises. This will allow MSEs like us to participate and contribute to the competitive bidding process.</p>	<p>No change in the tender document.</p> <p>The terms & conditions of the tender shall prevail .</p>

Clause 10.2,10.5,4.0 /Section-II, Clause 13.2/section -V	<p>We want to participate in Tender No CON/DCONT/TANK CONT/2025 – for The Design , manufacturing ,testing & Supply of 500 numbers 20 feet High Cube (20'x8'x 9'6") tank containers for bulk Cement loading & transportation. Need to clarify about following points.</p> <p>1. As per Clause No 10.2, of Section - II We are required to make delivery at CONCOR, Telangana. Please confirm whether we can make delivery at nearest CONCOR DEPOT (i.e. ICD Khodiyar, Gujarat) so that will be beneficial to CONCOR as well as Bidder.</p> <p>2. As per Clause No 13.2 of Section-V, Longitudinal Dynamic Impact test required to be fulfilled by Bidder. As of Now, In India, there is no facility for such test and for conduction test at Out of India, Cost will be higher. For Establishing facility in India, Time and cost for such facility will be much more. How the CONCOR will support to manufacture in this requirement?beacuse tender time is 240 days only.</p> <p>3.As per Clause No 10.5 of Section - II, During the Evaluation (Technical/Financial), If development Manufacturer do not qualify then will whole quantity will be alloted to reputed tank Manufacturers.</p>	<p>No change in the tender document.</p> <p>The terms & conditions of the tender shall prevail.</p> <p>All the documents shall be signed manually or digitally by authorized signatory of the bidder and uploaded in bid document by digital signature of authorized signatory of the bidder as per terms & conditions mentioned in tender.</p>

Please response ASAP.</p>
